DECLARATION OF RISK AND EXCLUSION OF LIABILITY

I certify that I am aware that rafting contains risks that can cause Severe injury or death.

I understand that rafting involves certain risks of injury, dangerous to life, health and bodily integrity. Also, I understand that rafting trips can be conducted at a site distant from the place where you can quickly and adequately to provide medical assistance.

I understand and agree that neither my rafting trip leader, skipper nor organizer of rafting, nor any of their employees (hereinafter referred to as the excluded parties) can not be held responsible for any injury, death, or for another, to me personally, my family, relatives or heirs of damages that may arise from my participation in this rafting or due to the negligence of any party, including the excluded party, either passively or actively. And if we are allowed to participate in this excitement voluntarily accept all the risks associated with, regardless of whether they are predictable ii unpredictable, which may arise joining my trip.

At the same time i declare that neither I, nor my family, heirs or legal representatives will not require the initiation of proceedings against the leaders of rafting, skipper or the organizers of rafting. I also know that rafting is physically strenuous activity, it will be during this activity, strain, and expressly declare that I accept risks and injuries from a heart attack, which may occur from shock, hypothermia and the like, and that the above-mentioned persons and organizers of rafting do not hold responsible.

Furthermore, I declare that I am of legal age and legally competent to sign the Declaration of exclusion of liability or that I have written consent from a parent or legal guardian.
